- For existing infestations apply 15ml per litre at 3 day intervals for 2 weeks.
- Then resume regular weekly sprays.

Moderate to Low Population Pressure and Existing Infestation

- Apply 10ml per litre at 7 day intervals for at least 4 applications.
- Monitor pest nymph numbers on a weekly basis.

Apply a minimum of 2 litres product per 1000m², regardless of application equipment.

Storage Handling and Compatibility

Store product in closed container under dark cool conditions.

Use the spray within 8 hours of mixing.

Additional wetting /sticking agents are not usually required.

NeemAQ will not harm bees or beneficial insects
